I am pleased to share with you the 2022 Annual Report for HEALWA. This is HEALWA's first communication with you since the pandemic ended, and I am excited and optimistic about the future of this evidence-based health information library program for eligible licensed Washington healthcare providers. Already, I am grateful for and collaborating with the Office of Health & Science to ensure that healthcare providers with responsibility for epidemiology, data, and science activities are accessing evidence-based health information resources. Patricia Devine is in her third year as HEALWA's Director and energized by those she is meeting with and looking forward to connecting with more of you in 2023 via social media and meetings.

There is important healthcare workforce development work to be done, and HEALWA is committed to work with state associations and other stakeholders to support the lifelong learning and health information literacy needs of clinicians, nurses, and allied health professionals. I would like to stress the important of elevating equitable digital access to evidence-based information throughout Washington State, shared-decision making between providers and patients, and combatting health misinformation. This past year HEALWA added access to the New England Journal of Medicine, JAMA and the suite of accompanying JAMA specialty journals. Also, HEALWA improved access to dermatology diagnostic tools via VisualDX's DermExpert.

On tap for the next year, 2023, we are following a variety of issues impacting healthcare including: telehealth; shared decision making; future pandemic preparedness; mental and behavioral health; and other priorities. We are prepared to work with Washington health professions associations, the state legislature and the Washington Department of Health to support current health information needs. HEALWA is working hard to elevate the priorities and will be a valuable resource to keep you current and provide you with an online library of health information resources via the HEALWA website at: https://healwa.org.


